We, the undersigned natural persons of the age of twenty-one years or more, all of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is RANGER GENERAL AGENCY, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purposes for which the corporation is organized are:

To act as general agent for one or more admitted and licensed insurance companies or carriers, other than life insurance companies or carriers, in a supervisory capacity, provided that it may not act as a local recording agent or solicitor as such terms are defined in Section 2, Article 21.14 of the Texas Insurance Code.

To manufacture, purchase or otherwise acquire, invest in, own, mortgage, pledge, sell, assign and transfer or otherwise dispose of, trade, deal in and deal with goods, wares and merchandise and personal property of every class and description.

To erect or repair any building or improvement and to accumulate and lend money for said purposes, and to purchase, sell and subdivide real property in towns, cities and villages and their suburbs not extending more than two miles beyond their limits and to accumulate and lend money for that purpose.

In general, to carry on any other business and do any other acts in connection with the foregoing and to have and exercise all powers conferred by the laws of the State of Texas upon corporations formed under the Texas Business Corporation Act, and to do any or all of the things hereinabove set forth to the same extent as natural persons might or could do.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) shares of the par value of One Dollar (\$1.00) each.

#### ARTICLE V

The corporation will not commence business until it has received for the issuance of its shares consideration of the value of not less than One Thousand Dollars (\$1,000.00), consisting of money, labor done or property.

#### ARTICLE VI

The post office address of the corporation's initial registered office is 846 Bank of the Southwest Building, Houston 2, Texas, and the name of its initial registered agent at such address is Paul E. Martin.

#### ARTICLE VII

"To erect or repair any building or improvement and to purchase, sell and subdivide real property in towns, cities and villages and their suburbs not extending more than two miles beyond their limits.

"To be the underwriting manager or general manager of associations or pools of insurance companies, and of individual companies, and to act as general agent for one or more admitted and licensed, or non-admitted and unlicensed, insurance companies or carriers, including life insurance companies or carriers, in a supervisory capacity, and to receive and place applications for fire, casualty, hail, marine, accident, health, life, and all other and related lines of insurance, as well as reinsurance, in such supervisory capacity, and to act as a reinsurance broker, provided that it may not act as a local recording agent or solicitor as such terms are defined in Section 2, Article 21.14, Texas Insurance Code, nor act as a life insurance agent as such term is defined in the Texas Insurance Code.

"To act as the attorney-in-fact for a reciprocal or interinsurance exchange organized and operating under the provisions of Chapter 19, Texas Insurance Code.

"To manufacture, purchase or otherwise acquire, invest in, own, mortgage, pledge, sell, lease, assign and transfer or otherwise dispose of, trade, deal in or deal with goods, wares and merchandise and personal property of every class and description.

"To erect or repair any building or improvement and to purchase, sell and subdivide real property in towns, cities and villages and their suburbs not extending more than two miles beyond their limits.
