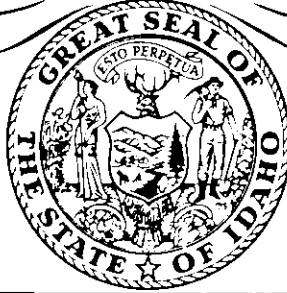

ARTICLES OF INCORPORATION

OF

CUSTOMCRAFT, Inc.

WE, THE UNDERSIGNED natural persons of the age of twenty-one years or more, acting as incorporators under the Idaho General Business Corporations Act, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is **Customcraft, Inc.**

ARTICLE II - DURATION

The duration of this corporation is perpetual.

ARTICLE III - PURPOSE

The nature of the business or purposes to be conducted or promoted are: For the purposes of construction and sale of homes and/or commercial buildings, holding second mortgages, and dealing in and with articles and property of all kinds and rendering services of all kinds; and to engage in any lawful act or activity for which corporations may be organized under the laws of Idaho.

ARTICLES IV - SHARES

The aggregate number of shares which this corporation shall have authority to issue is one hundred (100) shares at no par value. All stock of the corporation

shall be of the same class, common, and shall have the same rights, voting power and preferences and be subject to the same restrictions. The Board of Directors or the shareholders may adopt by-laws restraining the alienation of shares and providing for the purchase or redemption by the Corporation of its shares.

ARTICLE V - PREEMPTIVE RIGHTS

The shareholders shall have preemptive rights to acquire additional shares of the corporation.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The location and post office address of this corporation's initial registered office is 610 Pershing Avenue, Pocatello, Idaho 83201. The name of the initial registered agent at such address is Greg Helm.


ARTICLE X - COMMON DIRECTORS - TRANSACTIONS

entity in which one or more of this corporation's Directors are directors or officers or are financially interested, shall be either void or voidable because of such relationship or interest, or because such Director or Directors are present at the meeting of the Board of Directors, or a committee thereof which authorizes, approves or ratifies such contract or transaction, or because his or their votes are counted for such purpose and each such director of this corporation is hereby released from liability which might otherwise exist from such contract if: (a) the fact of such relationship or interest is disclosed or known to the Board of Directors or committee which authorizes, approves or ratifies the contract; or (b) the transaction is approved by sufficient vote or consent without counting the votes or consents of such interested Director; or (c) the fact of such relationship or interest is disclosed or known to the shareholders entitled to vote or written consent; or (d) the contract or transaction is fair and reasonable to the corporation. If the fact of such relationship or interest is known then the common or interested Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or committee thereof which authorizes, approves, or ratifies such contract or transaction.


