ARTICLES OF INCORPORATION

OF

CARLIN BAY COMMUNITY CHURCH, INC.

I, the undersigned, being a natural person of full age and a citizen of the United States and the State of Idaho, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, do adopt the following Articles of Incorporation for such corporation.

ı.

The name of the corporation shall be CARLIN BAY COMMUNITY CHURCH, INC.

II.

The corporation is not being organized for pecuniary profit, and no part of its income shall be distributable to, or otherwise inure to the benefit of its members or officers.

III.

The period of its duration is perpetual.

IV.

The object, business and purpose of this corporation is to preach the gospet, to administer the ordinances of the New Testament, to minister to the spiritual needs of its members and all people everywhere, to train Christian workers for the Lord's work, and to further the evangelization of the world by converting men, women and children to a saving faith in the Lord Jesus Christ.

٧.

Membership in this corporation shall be open to all persons, and the rights and privileges of membership shall be fully set forth in the by-laws of this corporation.

The location and mailing address of the initial registered office of the corporation shall be at the Carlin Bay Community Center, Route 2 Box 162A, Harrison, Idaho 83861, and the name of its initial registered agent at such address is Ronald D. Isakson.

VII.

Management of the affairs of this corporation shall be vested in its members, and the name and address of the clergyman who will initially serve as the spiritual leader of the church is the Rev. Ben Elliot of Route 2 Box 162 A, Harrison, Idaho.
