# ARTICLES OF INCORPORATION

HOPE COMMUNITY HEALTH CENTER, INGS HAY 21 AM 8: 22

The undersigned, acting as the incorporator of a nonprofit corporation ("Corporation under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, title 30, Idaho code ("Act"), adopts the following Articles of Incorporation ("Articles").

#### Article I Name

The name of the Corporation is "HOPE COMMUNITY HEALTH CENTER, INC.".

## **Article II Nonprofit Status**

The Corporation is a nonprofit corporation.

#### **Article III Period of Duration**

The period of duration of the Corporation is perpetual.

### Article IV Registered Office and Agent

The location of the Corporation is in the city of Bonners Ferry, County of Boundary, and in the State of Idaho. The mailing address of the initial registered office is: HOPE COMMUNITY HEALTH CENTER, INC., Post Office Box 1846, Bonners Ferry, Idaho 83805. The physical address of the initial registered office is 6488 Chinook Street, Bonners Ferry, Idaho 83805. The name of the initial registered agent at this address is Andrea Kramer.

# Article V Purposes

The purposes for which the Corporation is organized and will be operated are as follows:

- A. To establish and maintain a community health center and all things incidental thereto and all other purposes permitted under Idaho law.
- B. Charitable, religious, educational, or scientific within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such

- purposes, the making of distributions to organizations that qualify as exempt under such Section 501(c)(3).
- C. To exercise all powers granted by law necessary and proper to carry out the foregoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or other things of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefore, may not at that time lawfully carry on or do.

#### **Article VI Limitations**

No part of the net earning or the assets of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the activities of Corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time in such manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for the purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation. Upon dissolution, the incorporators or directors in approving the dissolution shall adopt a plan of dissolution indicating to whom the assets owned or held by the Corporation will be distributed after all the creditors have been paid. The Corporation shall follow Idaho Statute 30 for the process regarding dissolution.

## Article XI Bylaws

Provisions for the regulations of the internal affairs of the Corporation shall be set forth in the Bylaws.

The Board of Directors of the Corporation shall be authorized to amend the Corporation's Bylaws at a properly noticed special or regular meeting of the Board of Directors. The initial Board of Directors are as follows:
