KNOW ALL MEN BY THESE PRESENTS:- That we whose names are subscribed hereto, do under and in pursuance of the corporation laws of the State of Idaho and all amendments thereto, hereby organize ourselves into a body politic and corporate, and to that end execute the following Articles of Incorporation; and we do hereby set forth and declare as follows:

FIRST.

That the name of this corporation is, Allen Mercantile Company, Limited.

SECOND.

That the purposes for which this corporation is created are; conducting a general merchandising business, buying, selling, and dealing in general merchandise both at wholesale and retail, handling all classes of merchandise on commission or otherwise, including fuel, feed, mill stuff, grain, seeds, and provisions; acquiring by purchase, lease, or otherwise owning and holding such real estate, personal property, ware-houses, and buildings as may be necessary for properly conducting the business of this corporation; borrowing such money as may be necessary for the proper conduct of the business of this corporation; hypothecating and mortgaging any and all property of this corporation, both real and personal, including ware-house receipts, shipping receipts, bills of lading, as security for

the payment of moneys so borrowed, and the doing and performing of all such acts and things as may be essential to the full and complete carrying out of the purposes above set forth.

THIRD.

That the place where the principal business of this corporation shall be transacted, is Twin Falls, Cassia County, Idaho.

FOURTH.

That the term for which this corporation shall exist is fifty (50) years.

FIFTH.

That the number of directors of this corporation shall be three.

SIXTH.

That the amount of the capital stock of this corporation shall be Twenty-five Thousand Dollars, divided into Two Hundred and Fifty shares of the par value of One Hundred Dollars each.

SEVENTH.

That the amount of the capital stock of this corporation that has been actually subscribed, and the number of shares subscribed by each subscriber are as follows:
