

ARTICLES OF INCORPORATION.

Know all men by these presents that we, the subscribers hereto, have and do hereby associate ourselves together for the purpose of organizing a CORPORATION by virtue of the laws of Idaho, which corporation shall be and is hereby called and named

FRIEDMAN COMPANY LIMITED.

The purpose for which this corporation is formed is to do a general merchandise business, and to that end to do any and all things necessary and convenient to be done in and about the business of buying and selling goods and merchandise for profit; to acquire title to, own and sell all kinds of property, real and personal, when incident to the carrying on such merchandise business; to mortgage and hypothecate property of all kinds, and to take liens and mortgages upon all kinds of property in the course of its business.

The place where its principal business is to be transacted is the town of HAILEY, in the county of BLAINE and state of IDAHO.

The term for which this corporation is to exist is FIFTY YEARS.

The number of its DIRECTORS, is FIVE. And the names and residence of the persons who shall act as such Directors for the first year, hereby appointed, -are as follows, to-wit:-
