

ARTICLES OF INCORPORATION

PEOPLES ELECTRIC COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS:- That we, the undersigned, have voluntarily associated ourselves together for the purpose of organizing a private corporation, under and by virtue of the laws of the State of Idaho, and we do hereby set forth and declare as follows:

FIRST.

That the name of this corporation is, and shall be  
PEOPLES ELECTRIC COMPANY, LIMITED.

SECOND.

That the place where the principal business of this corporation shall be transacted, is Boise in the County of Ada, State of Idaho.

THIRD.

That the term for which this organization shall exist is fifty (50) years.

FOURTH.

That the purposes for which this organization is formed are, constructing, equipping, maintaining and operating, within Boise City and immediate vicinity, an electric light, heat and power plant to distribute electric current for purpose of heating, lighting and power and the doing and performing of all such other acts and things as may be essential to the full and complete carrying out of the purposes above set forth.

FIFTH.

That the number of directors of this corporation shall be
