

Articles of Incorporation (Non-Profit) Title 30, Chapters 21 and 30, Idaho Code

Article 1: The name of this corporation shall be: **Abundant Life Fellowship Inc.**

Article 2: The purpose for which this corporation is organized is:

- A. Primarily to engage in the specific business of operating a church.
- B. This corporation is a religious corporation and is not organized for the private gain of any person, organized under the Nonprofit Religious Corporation Law exclusively for religious purposes. This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code.
- C. The specific purpose of this corporation is to operate a church for religious purposes and be able to contract, rent, buy or sell personal and real property and to have and exercise all rights and powers conferred on a non-profit corporation under the laws of Idaho.

Article 7: The corporation ( Does  Does not) have voting members.



Article 9: The property of this corporation is irrevocably dedicated to religious and charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person, beyond reasonable compensation for the performance of tasks or services performed on the behalf of the corporation.
