# FIRST AMENDMENT AUC TO AMENDED AND RESTATED ARTICLES OF STATE OF STATE COEUR D'ALENE HOMES PHASE II, INC.

Pursuant to the provisions of Chapter 3, Title 30 of the Idaho Nonprofit Corporation Act, Coeur D'Alene Homes Phase II, Inc., an Idaho nonprofit corporation, formed on April 17, 2005, the undersigned hereby deletes Article VI(C) and replaces it with the following:

#### ARTICLE VI

C. In the event of the dissolution of the corporation or the winding up of its affairs, or other liquidation of its assets, the corporation's property shall not be conveyed to any organization created or operated for profit or to any individual for less than the fair market value of such property, and all assets remaining after the payment of the corporation's debt shall be conveyed or distributed only to Coeur d'Alene Homes, Inc., or if Coeur d'Alene Homes, Inc. is not then in existence, an organization or organizations created and operated for nonprofit purposes similar to those of the corporation: PROVIDED, however, that the corporation shall at all times have the power to convey any or all of its property to the Secretary of Housing and Urban Development for a public purpose.
