

1 Articles of Incorporation of the Standard
2 Mining Company, Limited.

4 Know all Men by these Presents, That We, the
5 undersigned, have this day voluntarily associated
6 ourselves together for the purpose of forming a
7 corporation, under the laws of the State of Idaho.
8 And we hereby certify:

9 First.

10 That the name of the said corporation is the "Stand-
11 ard Mining Company, Limited."

12 Second.

13 That the purposes for which it is formed are to
14 carry on the business of exploring & mining for
15 gold & silver in the State of Idaho, & to hold,
16 lease, acquire, buy, sell, transfer & convey mines
17 & mining claims of gold & silver, or of either,
18 together with other property incident to such
19 business of exploring & mining.

20 Third.

21 That the place where its principal business is to
22 be transacted shall be the town of Payette, County
23 of Canyon, State of Idaho.

25 That the term for which it is to exist is Fifty (50)
26 years from & after the date of its incorporation.

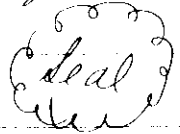
