- 1.) Please pay special attention to the mailing address. If it is incorrect, please make the appropriate corrections.
- 2.) **NOTE:** The name of the business entity cannot be altered on the annual report form. If the registered agent has changed or moved, please make that correction on this form. The registered agent must be found IN IDAHO at a PHYSICAL ADDRESS. PO Boxes WILL NOT be accepted. If report is for a Limited Liability please refer to #4 below.
- 3.) Corporation: Enter names and addresses of ONLY the president, secretary, and directors in block 4.
- 4.) Limited Liability Company: Enter the names and addresses of the managers or members in block 4.
- 5.) **NOTE:** Putting "same as last year" WILL NOT be accepted.
- 6.) Limited Liability Company: If the registered agent has been changed in block 2, then the NEW registered agent must accept that position by signing in block 5.
- 7.) Corporation: Block 6 must be signed by an officer or chairman of the board of the corporation. Signer must specify his or her title.
- 8.) Limited Liability Company: Block 6 must be signed by a manager or member, who must specify his or her title.
- 9.) If new registered Agent, please sign block 5.
