ARTICLES OF INCORPORATION

OF

IDA-PO AG, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is IDA-PO AG, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to carry on all lawful business, as provided by the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares with no par value.

FIFTH: Provisions denying preemptive rights are: those authorized by statute.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are set forth in the By-laws of the corporation.

SEVENTH: The address of the initial registered office of the corporation is 850 East, 800 North, Rupert, Idaho 83350, and the name of its initial registered agent at such address is R. Cregg Poteet.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is two (2), and directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

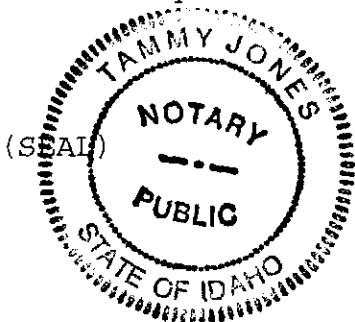
