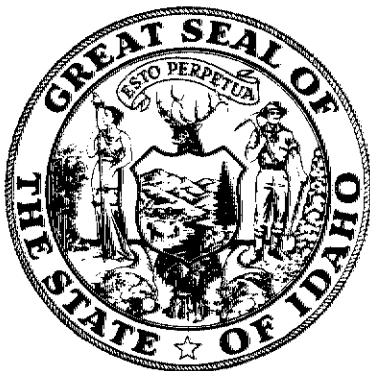

We, the undersigned, Arlo G. Lott, President, and Andrew D. Lott, Secretary, of Apollo Transit, Inc., an Idaho corporation, do hereby certify:

That as of July 28, 1987, the following amendment to the Articles of Incorporation of Apollo Transit, Inc., was consented to and authorized by the unanimous written consent of the holders of all of the issued and outstanding stock of said corporation entitled to vote, in accordance with the provisions of Section 30-146(5) of the Idaho Code.

RESOLVED, that the Articles of Incorporation of Apollo Transit, Inc., be amended as follows:

Article I of the original Articles of Incorporation shall be repealed, and the following Article shall be adopted to replace said Article I:

"ARTICLE I

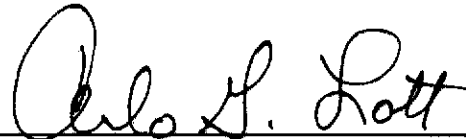

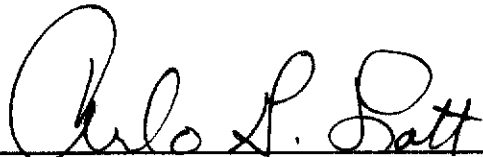

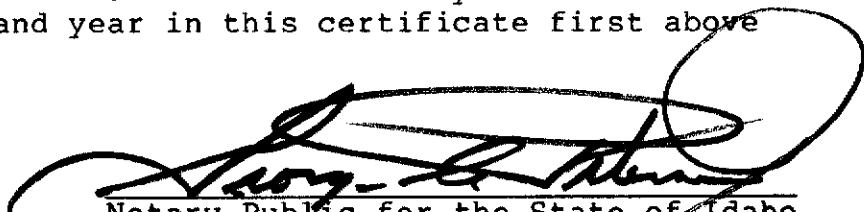
