The undersigned, acting as sole incorporator of a corporation aunder the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is La Shaw Trucking, Inc.

The period of the corporation's duration is perpetual.
