ARTICLES OF INCORPORATION
OF
LINDSAY SOFT WATER OF NAMPA, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

FIRST: That the name of said corporation shall be LINDSAY SOFT WATER OF NAMPA, INC.

SECOND: That the purposes for which said corporation is formed are:

(A). To sell and lease equipment, products, materials, and services for the producing of soft water, both domestic and commercial and further for the conditioning of water.

(B). To purchase or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage or otherwise dispose of, and to invest, trade and deal in and with real property, any and all interests therein.

(C). To purchase or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, pledge or otherwise dispose of to guarantee, and to invest, trade and deal in and with personal property of every kind and description.

(D). To enter into any kind of an agreement or contract, cooperative or profit sharing plan, with its officers or employees that the corporation may deem advantageous or expedient or otherwise to reward or pay such persons for their services as the directors may deem fit.

(E). To purchase, lease, or otherwise acquire, in whole or in part, the business, good will, rights, franchises and property of every kind, and to undertake the whole or any part of the assets of or liabilities of any person, firm, association or corporation engaged in or authorized to conduct any business similar to any business authorized to be conducted by

this corporation, or owning property necessary or suitable for its purposes, and to pay for the same in cash, in stock or bonds of this company or otherwise; to hold or in any manner dispose of the whole or any part of the property or business so acquired, and to exercise all the powers necessary or incidental to the conduct of such business.

(F). To borrow money, to issue bonds, debentures, notes, and other obligations of this corporation from time to time, for any of the objects or purposes of this corporation, and to mortgage, pledge, hypothecate, and or convey in trust, any or all of its property, to secure the payment thereof.

(G). To discount and negotiate promissory notes, drafts, bills of exchange, and other evidences of debt; to enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any sub-division, district or department thereof.

(H). To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinabove enumerated, or calculated, directly or indirectly, to promote the interest of the corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its business, to do any and all acts and things, and to exercise any and all other powers, which a co-partner or natural person could do or exercise, and which now or hereafter may be authorized by law, and in any part of the world.

(I). The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall in nowise be limited or restricted, by reference to or inference from the terms of any clause, but shall be regarded as independent

purposes and powers; and no recitation, expression, or declaration or specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

THIRD: The duration of this corporation shall be perpetual.

FOURTH: The location and post office address of the registered office of the corporation in the State of Idaho shall be: LINDSAY SOFT WATER OF NAMPA, INC., 535 Caldwell Boulevard, Nampa, Canyon County, Idaho, which said place shall be the principal office for the transaction of the business of this corporation.

FIFTH: That this corporation is authorized to issue only one class of shares of stock, the total number of which said shares is Two Hundred Fifty (250) and that said shares shall have a par value of ONE HUNDRED and NO/100 (\$100.00) DOLLARS for each of said shares and that the aggregate par value of said shares is the sum of TWENTY FIVE THOUSAND and NO/100 (\$25,000.00) DOLLARS; such stock may be issued by the corporation from time to time by the corporation Directors thereof for the consideration as may be fixed by said corporation Directors.

SIXTH: The name and post office address of each of the incorporators, and a statement of the number of shares subscribed by each is as follows:

EIGHTH: The Board of Directors shall have the power and authority to formulate, repeal and amend By-Laws of the corporation and to adopt new By-Laws, subject to the restrictions provided by the laws of the State of Idaho.


