ARTICLES OF INCORPORATION

GLIDERS OF IDAHO, INC.

The undersigned natural person of the age of 18 years or more, acting as incorporator of a corporation under the General Business Corporations Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Gliders of Idaho, Inc..

ARTICLE II

The corporation shall exist perpetually, unless sooner dissolved or disincorporated according to law.

ARTICLE III

The purpose or purposes for which the corporation is organized shall be to operate a commercial glider ride business, and to own, use, buy, sell, lease, hire and deal in and with all articles of property and to render services of all kinds, and to engage in any lawful act or activity for which corporations may be organized in the State of Idaho.

ARTICLE IV

The corporation shall have authority to issue a total of One Thousand (1000) shares of capital stock all of which shares shall be of one class of no par value and shall be designated as Common Stock.

ARTICLE V

The address of the initial registered office of the corporation shall be Friedman Memorial Airport, Highway 75 P.O. Box 119 Hailey, Idaho 83333, and the name of its initial registered agent at such address is Geoff D. Sjoberg.

ARTICLE VI

The name and address of the persons to serve on the initial Board of Directors until the first annual meeting of stockholders or until successors are elected and shall qualify are: Geoff D. Sjoberg.

ARTICLE VII

The corporation shall have all powers enumerated under the General Business Corporations law, and those set forth in the By-Laws of the corporation.

ARTICLE VIII

The number of directors of the corporation shall be fixed from time to time by its By-Laws and may be increased or decreased as therein provided.

ARTICLE IX
