ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS: That We, ROBERT S. WRIGHT whose address is Post Office Box 234, Ketchum, Idaho, MARGARET A. WRIGHT whose address is Post Office Box 234, Ketchum, Idaho, and JAMES B. DONART whose address is 32 East Main Street, Weiser, Idaho, desiring to form a corporation under and by virtue of the laws of the State of Idaho do hereby associate ourselves together for said purpose and execute, acknowledge, adopt and file the following Articles of Incorporation:

ARTICLE I.

The name of this corporation shall be ROBERT S. WRIGHT ADVERTISING, INC.

ARTICLE II.

The names of the persons so hereby associating themselves together for the purposes aforesaid are: Robert S. Wright, Post Office Box 234, Ketchum, Idaho; Margaret A. Wright, Post Office Box 234, Ketchum, Idaho, and James B. Donart, 32 East Main Street, Weiser, Idaho, each of whom is a resident and citizen of the United States of America and of the State of Idaho, and over the age of twenty-one years;

ARTICLE III.

The principal place of business and registered office of this corporation shall be Post Office Box 95, Sun Valley, Idaho, and there may be such other subordinate and branch offices hereafter established either within or without the State of Idaho, as the Board of Directors of said corporation may determine;

ARTICLE IV.

That the general nature of the business to be transacted by this corporation

and objects and purposes for which this corporation is formed are as follows:

To conduct the general business of an advertising agency and public relations service; to contract to perform art work and to make up and to contract to have the same performed, to compose and place all types of advertising and to contract for the placement of the same in magazines, newspapers and all forms of publication, radio, television, billboards and other media for the dissemination of promotional and advertising material, to enter to sub-agency agreements, to contract for compensation on standard agency commissions based upon a percentage of gross charges for placement of advertising and to collect such other fees for the performance of any of the aforesaid services as may be necessary; to engage in the business of promoting, selling and distributing advertising material, advertising displays and to transact the business of advertising, promoting, developing the business of other corporations, partnerships or individuals for hire or upon commission, or otherwise, by and through the means of preparing advertising for other corporations, partnerships or individuals and of advertising the business, commodities or other property, real, personal or mixed of other corporations, partnerships or individuals, in newspapers, books, booklets, prospectuses, magazines, circulars, pamphlets, other similar literature and other advertising media.

To acquire by purchase or lease real or personal property as may from time to time be necessary or expedient in carrying out the business for which this corporation is being formed; to acquire an interest in other business operations including the right to buy or sell the stock of other corporations; to borrow money and to issue as evidence thereof its notes or bonds, or other evidence of such indebtedness and to secure the payment of the same by the execution of a pledge, Deed, Trust Deed, Mortgage or Chattel Mortgage, Title Retaining Note or

Contract upon any or all of its real or personal property; to sell or convey all or any of its corporate property whether real or personal giving to the purchaser thereof as full and complete title as may be possessed by said corporation; to do any and all acts hereinbefore set forth and such other acts and deeds as may be necessary and expedient in the operation of the business so to be conducted by this corporation as hereinbefore set forth and for the accomplishment of the purposes for which this corporation is formed.

ARTICLE V.

ARTICLE VII.

That the government and management of the business of this corporation shall be vested in a Board of three (3) Directors and that Robert S. Wright, Margaret A. Wright and James B. Donart shall be and constitute the First Board of Directors of this corporation and shall hold their offices as such until their successors are elected and qualified;


ARTICLE VIII.




