ARTICLES OF INCORPORATION
OF

TO CREATE A CORPORATION UNDER THE PROVISIONS OF THE CORPORATION
LAWS OF THE STATE OF IDAHO, WE, THE FOLLOWING PERSONS, DO HEREBY
ASSOCIATE OURSELVES, AND CERTIFY AS FOLLOWS:

ARTICLE 1

THE NAME OF THIS COMPANY SHALL BE SPECIALTY SPRAYS, INC.

ARTICLE 2

IN FURTHERANCE OF THE GENERAL POWERS OF THIS CORPORATION, IT
SHALL HAVE THE FOLLOWING PRIVILEGES IN ITS BUSINESS:

- A. TO PURCHASE, LEASE, OR DEAL IN REAL PROPERTIES OF ALL DESCRIPTIONS
- B. TO PURCHASE, LEASE, OR DEAL IN PERSONAL PROPERTY OF ALL KINDS
- C. TO ENTER INTO AND PERFORM CONTRACTS OF EVERY KIND, TO BECOME A PARTNER IN ANY BUSINESS VENTURE, AND TO ACQUIRE AND DEAL IN ITS OWN STOCK AND SECURITIES, SHOULD THE NECESSITY ARISE,
- D. TO ESTABLISH PENSION, PROFIT SHARING, AND OTHER EMPLOYEE BENEFIT PROGRAMS
- E. TO ACQUIRE OTHER BUSINESSES, EITHER THROUGH PURCHASE, OR BY EXCHANGE OF ASSETS, GOODWILL, OR OTHER CONSIDERATION
- F. TO APPLY FOR AND REGISTER PATENTS, TRADEMARKS, OR ANY OTHER INTANGIBLE OBJECTS
- G. TO BORROW MONEY AS NECESSARY
- H. TO CARRY ON ANY LAWFUL BUSINESS IN CONNECTION WITH THE ENUMERATED POWERS, NOT TO BE CONSTRUED AS LIMITING OR PROSCRIBING ANY POWERS NOT HEREIN EXPRESSLY CLAIMED.

ARTICLE 3

TOTAL AUTHORIZED CAPITAL STOCK THAT SHALL BE ISSUED BY THIS CORPORATION SHALL BE 200 SHARES OF THE PAR VALUE OF \$100 EACH, FOR A TOTAL CAPITAL OF \$20,000.

ARTICLE 4

THE NATURE OF THE BUSINESS CONDUCTED BY THIS COMPANY SHALL BE:
APPLICATION OF SPRAYS, FERTILIZERS, PESTICIDES, TOGETHER
WITH ALL RELATED ACTIVITIES GERMANE TO THIS BUSINESS.

ARTICLE 5
THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.


