CERTIFICATE OF ARTICLES OF AMENDMENT

TO THE

ARTICLES OF INCORPORATION

OF

MEDICAL EDUCATION FOUNDATION, INC.

BE IT KNOWN That we, the undersigned, President and Secretary, respectively of MEDICAL EDUCATION FOUNDATION, INC., an Idaho corporation, do hereby certify in accordance with the provisions of Section 30-146, Idaho Code, as follows:

- 1. That a meeting of the members of the Medical Education Foundation, Inc., was held at 300 North Sixth Street, Boise, Idaho, at 12:00 noon on Thursday, June 15, 1978, pursuant to call and waiver of notice and consent to meeting.
- 2. That at said meeting the following resolution was unanimously adopted, to-wit:

BE IT RESOLVED, That the Articles of Incorporation of this corporation be, and they hereby are, amended by inserting after the first sentence of Article II, which now reads as follows:

"The purposes and objects for which the corporation is formed are:"

the following language:

"This corporation is formed exclusively for charitable, educational and scientific purposes. Said purposes are to be carried out by the teaching of scientific or medical matters;".

BE IT FURTHER RESOLVED, That Article V of the Articles of Incorporation of this corporation be amended by adding thereto the following language:

"provided, however, that should the corporation be terminated or dissolved for any reason whatever, the assets of the corporation will be distributed to such organization or organizations that are organized and operated exclusively for charitable, educational, and scientific purposes, and have been recognized as exempt under Section 501(c)(3) of the Internal Revenue Code."

BE IT FURTHER RESOLVED, That the President and Secretary of the corporation be, and they hereby are, directed and empowered to cause the proper certificate of the amendment to articles of incorporation of this corporation to be executed and

filed with the Secretary of State of the State of Idaho, and in such other places within and without the State of Idaho as may be necessary, all in compliance with the statutes of the State of Idaho in this case made and provided."

And it appearing by certificate attached hereto, marked Exhibit A, that notice was given for four weeks prior to the date of this meeting that the Articles of Incorporation would be amended, pursuant to Chapter 11, Title 30, Idaho Code, the meeting was duly held pursuant to law.

IN WITNESS WHEREOF, We, the President and the Secretary, respectively, of said corporation, do on behalf of the corporation execute the foregoing Articles of Amendment to the Articles of Incorporation of the MEDICAL EDUCATION FOUNDATION, INC., an Idaho corporation, in triplicate this day of June, 1978.
