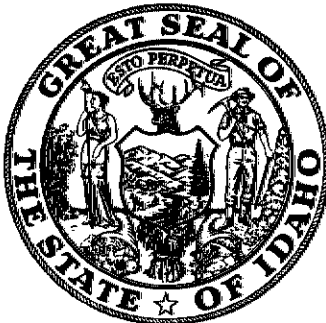

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is
Beck Enterprises, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to engage in all business activities authorized and permitted under the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50 shares having a par value of \$100.00 per share.

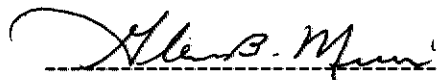

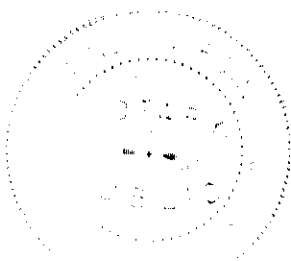
