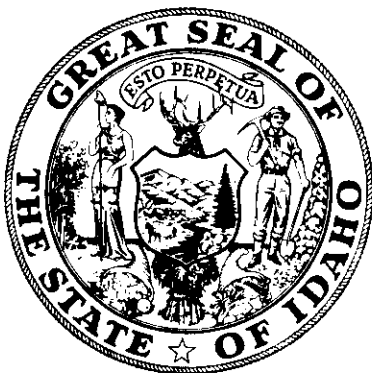

ARTICLES OF INCORPORATION

The undersigned being all natural persons of age twenty-one (21) or more, and acting as incorporators of the corporation under the Idaho Incorporation's Act adopt the following Articles of Incorporation.

I

The name of this corporation shall be HANK'S AG-CO, INC.

II

The term of this corporation shall be perpetual.

III

The purpose of this corporation is to engage in the business of buying and selling and spreading liquid fertilizer and other fertilizers, and to engage in other business not forbidden by law.

IV

The name of the registered agent shall be Henry Hunter. The address of the initial registered office is 1018 Linda Place, Pocatello, ID 83201.

V

It shall have authority to issue five thousand (5,000) shares of common stock at a par value of one dollar (\$1.00) per share, for an aggregate par value of five thousand dollars (\$5,000).
