We, the undersigned incorporators, hereby associate ourselves together to form and establish a corporation not for profit under the laws of the State of Idaho, pursuant to Title 30, Chapter 3, Idaho Code.

ARTICLE ONE

NAME AND LOCATION

The name of the corporation shall be BOUNDARY COUNTY YOUTH CRISIS AND DOMESTIC VIOLENCE HOTLINE, INC., and its location shall be Kootenai and First Street, City of Bonners Ferry, County of Boundary, State of Idaho.

ARTICLE TWO

DURATION

The period of duration of this non-profit corporation shalf be perpetual.

ARTICLE THREE

PURPOSE CLAUSE

The purpose for which this Corporation is formed is to provide a 24-hour per day, confidential, accurate information and referral resource to the people of Boundary County; to provide trained non-judgmental listeners; and to assist people experiencing stress and discourage inappropriate choice of behavior due to stress; to cooperate with all levels of government, local, state, and federal, and with all interested private individuals and legal entities in the furthering of all such purposes; to accept and use any federal or state aid funds available, and any private funds which may be made available to the corporation for its use and purposes; to make all

necessary studies and surveys; to exercise those powers commonly exercised by natural persons and to do all acts or things useful or incidental to the purposes for which this corporation is constituted.

ARTICLE FOUR MEMBERSHIP

This corporation shall have no members. The conditions and regulations of participants and the rights and other privileges of the participants shall be determined and fixed by the by-laws.

ARTICLE FIVE

BOARD OF DIRECTORS

The affairs of this corporation shall be managed by a board of directors consisting of five (5) members. The responsibilities and membership of this board shall be as determined and fixed by the by-laws of this corporation.
