

ARTICLES OF INCORPORATION
OF
CRAWFORD MERCANTILE COMPANY

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned have voluntarily associated ourselves together for the purpose of forming a private corporation under and by virtue of the laws of the state of Idaho, and do therefore make and acknowledge this certificate in writing, which when filed shall constitute the articles of incorporation of the "CRAWFORD MERCANTILE COMPANY".

ARTICLE I

The name of this corporation shall be the "CRAWFORD MERCANTILE COMPANY".

ARTICLE II

The purposes for which this corporation is formed are to conduct a general retail and wholesale mercantile business, and to do and perform all things whatsoever necessary to such business.

ARTICLE III

The term of existence of this corporation shall be fifty years from and after the filing of these articles of incorporation.

ARTICLE IV

The Capital Stock of said corporation shall consist of two hundred and fifty shares of the par value of one hundred dollars each.

ARTICLE V

The principal office of said company and the principal place of business thereof shall be at Crawford, Boise County, Idaho.

ARTICLE VI

No person shall be a member of the Board of Directors of said company, nor President or Vice President thereof, unless he or she shall be the holder of not less than five shares of the capital stock thereof.

ARTICLE VII

The holders of the Capital Stock of this corporation, shall be entitled to cast, at all meetings of the stockholders thereof, one vote for each share of said Capital Stock.

ARTICLE VIII

The annual meeting of the stockholders of this corporation shall be held at the office of said corporation at Crawford, Boise County, Idaho, on the first Saturday in November of each and every year.

ARTICLE IX

The number of Directors for this corporation shall be five, and the names of those who shall act as such Directors for the first year and until their successors in office shall have been elected and qualified are:

L. A. Gorton, J. D. Patterson, T. L. Worthington, H. C. Sims and F. A. Kerby.

ARTICLE X

The officers of this corporation, in addition to the Board of Directors, shall be President, first Vice President, second Vice President, Secretary & Treasurer and General Manager, each of whom shall be chosen by the Board of Directors and shall hold office for the term of one year or until his successors shall have been elected and qualified. And each of said officers shall be a member of the Board of Directors.

ARTICLE XI

Ten thousand dollars of the amount of the Capital Stock of this corporation has been subscribed, and the number of shares thereof by each shareholder subscribed is as follows:-

E. O. Patterson,	20 shares,	\$2000.00.
T. L. Worthington,	20 shares,	\$2000.00.

F. A. Kerby,	10 shares,	\$1000.00.

ARTICLE XII

The manner of holding and conducting meetings of the stockholders of this corporation shall be as determined in the by-laws thereof, hereafter by the said stockholders to be adopted.

ARTICLE XIII

The Board of Directors shall have power to make such prudential rules for the management of the affairs of this corporation, not inconsistent with the laws of the state of Idaho, for the purpose of conducting all business within the object and purpose of this corporation, as shall be by said Board deemed proper.
