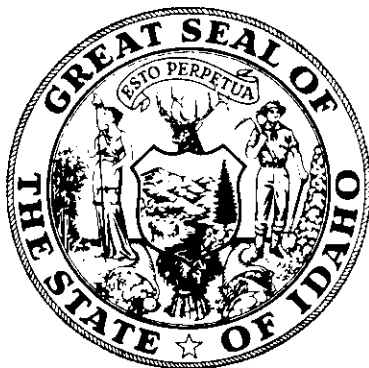

ARTICLES OF INCORPORATION  
OF

KNOW ALL MEN BY THESE PRESENTS that we, ROBERT R. RUSHTON, WILLINE B. RUSHTON, HERBERT B. HESS and SHERRY J. HESS, citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end we do hereby certify:

I

The name of this corporation shall be: H & R TRANSPORT, INC.

II

The period of existence of this corporation shall be perpetual.

III

The purpose for which the corporation is formed is to conduct a general transport business for hire and for the transaction of any and all lawful business for which corporations may be incorporated under the General Business Corporation Act of the State of Idaho as the same now provides.

The total authorized capital stock of this corporation shall be \$100,000.00, divided into 10,000 shares of the par value of \$10.00 each.

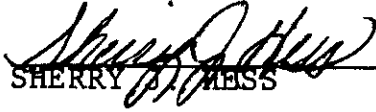
