ARTICLES OF INCORPORATION

Walking by Faith, Inc.



The undersigned, being over the age of eighteen years for the purpose of forming a corporation under the Idaho Business Corporation certify and adopt the following.

Articles of Incorporation

Article I

The name of this corporation shall be Walking by Faith, Inc.

Article II

It is our intention for Walking by Faitho exist in perpetuity.

Article III

Walking by FaithInc. shall have unrestricted ability to initiate and engage in any lawful act concerning any lawful business or activity for which corporations may be incorporated under the Idaho Business Incorporation Act.

Article IV

Walking by FaithInc. holds an aggregate of five thousand (5,000) shares, four thousand are voting shares with no par value except as designated by unanimous agreement by the directors, at their discretion. This limitation shall not apply to any act or omission occurring before the effective date of this paragraph. If the Idaho Business Corporation Act is amended to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director of the Corporation shall be eliminated or limited to the fullest extent permitted by the Idaho Business Corporation Act, as so amended. Any repeal or modification of the foregoing paragraph by the shareholders of the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.
