KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, ROY L. BOOKER, VERNE J. REYNOLDS, ROSS W. BROCKMAN and H. P. IKENBERRY, being natural persons of legal age and citizens of the United States of America; bona fide residents of the State of Idaho, and members of a church and religious organization, do hereby, in accordance with the rules, regulations and discipline of such Church and religious organization, associate ourselves together for the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and we do hereby adopt the following Articles of Incorporation, to-wit:

ARTICLE I.

The name of said corporation shall be "BOISE SECOND CHRISTIAN CHURCH, INC."

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

The location and postoffice address of its registered office and principal place of business shall be Boise, Ada County, Idaho.

ARTICLE IV.

The purposes for which this corporation is formed are:

To promote spiritual growth and to preach and teach the Word of God; to do missionary work around the world and do general religious work everywhere;

The rule of faith and practice of said Association shall be the New Testament;

To purchase, own, hold, lease, sell, convey, mortgage, or otherwise hypothecate real estate and personal property of all kinds and descriptions necessary or incident to or in connection with its church work;

To erect buildings and other structures necessary and proper for the carrying out of the purposes above

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being all of the Trustees and Directors of Boise Second Christian Church, Inc., a corporation formed on the 18th day of January, 1950 under and pursuant to Chapter 11, Title 30 of the Idaho Code relating to religious, social and benevolent corporations, and filed on the same date with the Secretary of State, State of Idaho, do hereby certify that the Articles of Incorporation, particularly Article I and Article VII thereof, as so filed, be, and the same are, hereby amended to read as follows:

ARTICLE I

"The name of said corporation shall be RED ROCK CHRISTIAN CHURCH OF BOISE, INC. "

ARTICLE VII

"Pecuniary profit is not the object of this corporation, and there is no capital stock and there are no shares of stock. In the event of dissolution of this corporation,

all remaining assets, after payment of the corporate debts and liabilities, shall be assigned, set over and transferred unto the South Idaho Christian Missionary Society, a non-profit religious corporation, organized and existing under and by virtue of the laws of the State of Idaho, and none of such assets shall be distributed to or inure to the benefit of any individual."


