ARTICLES OF INCORPORATION

OF

CREATIVE GLASS & MIRROR, INC.

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is CREATIVE GLASS & MIRROR, INC.

SECOND: The period of its duration is perpetual, unless dissolved by action of the stockholders or by operation of law.

THIRD: The purpose or purposes for which the corporation is organized are: to paint and etch glass and mirror for mobile home and other construction, and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The corporation shall have authority to issue 1000 shares, all of one class, no par value.

FIFTH: Provisions denying preemptive rights are:
