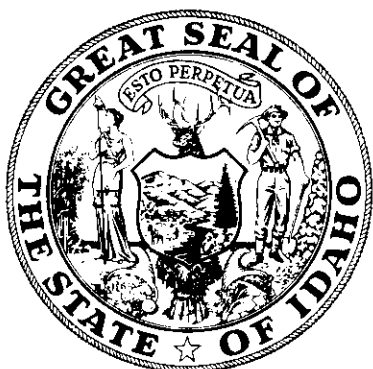

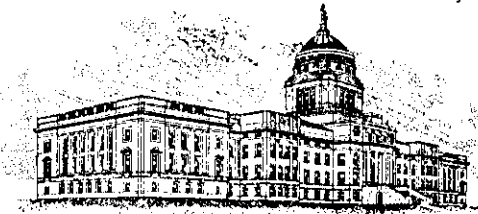

The undersigned person of legal age, acting as incorporator of a corporation under the Montana Business Corporation Act, adopts the following Articles of Incorporation.

1. The name of the corporation is S. J. ORR SERVICES, INC.
2. The period of its duration is perpetual.
3. The purpose or purposes for which the corporation is formed is refuse disposal, street cleaning, and any other lawful business or activity, whether in furtherance thereof, connected therewith, or related thereto or otherwise, except banking and insurance.





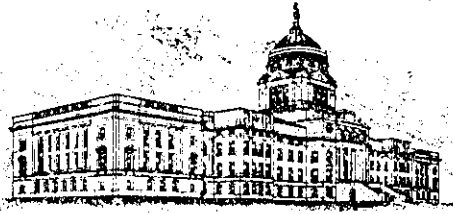

2. The Board of Directors of the corporation adopted the following resolution amending the Articles of Incorporation of S. J. Orr Services, Inc., as follows:



4. That no shares have yet been issued by said corporation.






