The undersigned person of legal age, acting as incorporator of a corporation under the Montana Business Corporation Act, adopts the following Articles of Incorporation.

- l. The name of the corporation is S. J. ORR SERVICES, INC.
 - 2. The period of its duration is perpetual.

The Board of Directors of S. J. Orr Services, Inc., a Montana business corporation, does hereby adopt the following amended Articles of Incorporation.

- 1. The name of the corporation is S.J. Orr Services, Inc.
- 2. The Board of Directors of the corporation adopted the following resolution amending the Articles of Incorporation of S. J. Orr Services, Inc., as follows:

"Resolved, that the Articles of Incorporation of S. J. Orr Services, Inc., shall be amended so as to increase the aggregate number of shares which the corporation shall have the authority to issue to 50,000 shares of common stock with the par value of each share being \$1.00 per share."

- 3. That said amendment to the Articles of Incorporation of S. J. Orr Services, Inc., was adopted on the 18th day of May, 1982, by all of the Directors of said corporation.
- 4. That no shares have yet been issued by said corporation.

The amendment to said Articles of Incorporation effects a change in the amount of authorized capital of said corporation from 50 shares of common stock with a par value of \$10.00 per share to 50,000 shares of common stock with a par value of \$1.00 per share.
