### ARTICLES OF INCORPORATION

# CRISTOBAL CONSTRUCTION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being each a natural person of full age and a citizen of the United States of America, in order to form a corporation for the purposes hereinafter stated, under and pursuant to provisions of the Idaho Business Corporation Act and the acts amendatory thereof and supplemental thereto, do hereby adopt the following articles of incorporation, to-wit:

I

#### NAME

The name of this corporation shall be Cristobal Construction, Inc.

II

# **PURPOSES**

The purposes for which this corporation is formed are as follows:

(a) To own and operate a general construction business, including the acquisition, ownership and use of such real and personal property as the board of directors deems necessary or advisable for use in connection with the operation of the business.

(b) To operate such other business or businesses as the board of directors may from time to time determine, and this corporation shall have all of the statutory powers conferred upon general business corporations by Chapter 1 of Title 30 of the Idaho Code, as it now exists or may hereafter be amended.

III

#### DURATION

The period of existence and duration of this corporation shall be perpetual.

# LOCATION OF THE REGISTERED OFFICE AND AGENT

The location of the registered office of the corporation shall be at 204 West Jackson Street in Mountain Home, Idaho, and the post office address of said corporation shall be 204 West Jackson Street, Mountain Home, Idaho 83647. The name of the registered agent of the corporation who may be found at the address above mentioned is John L. Cristobal.

# CAPITAL STOCK

The amount of the capital stock of this corporation shall be \$500,000, to consist of 5,000 shares of common stock of the par value of \$100 per share. No distinction shall exist between the shares of the corporation and all such shares shall have the same rights in the corporation.

All or any portion of the capital stock may be issued for cash or in payment for real or personal property, services or any other right or thing of value for the uses and purposes of the corporation, and when so issued shall become and be fully paid the same as though paid for in cash at par, and the board of directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock. No assessments or calls shall be made upon fully-paid capital stock.
