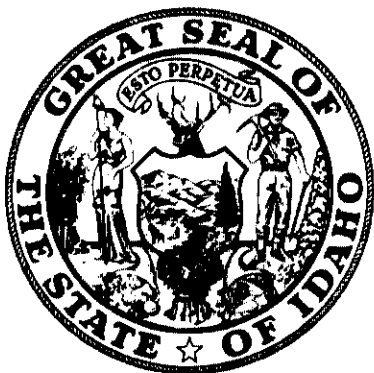

ARTICLES OF INCORPORATION
OF
FARMERS' MARKET AT SANDPOINT, INC.

KNOW ALL MEN BY THESE PRESENT: That we, the undersigned natural persons of lawful age and citizens of the United States, for the purpose of forming a nonprofit Corporation pursuant to the provisions of the Idaho Nonprofit Corporations Act (Title 30, Idaho Code) do hereby certify as follows:

FIRST

The name of the Corporation is Farmers' Market at Sandpoint, Inc.

SECOND

The Corporation is a nonprofit Corporation.

THIRD

The Corporation is to have perpetual existence.

FOURTH

The purposes for which the Corporation is organized shall be to provide for management and promotion of the Farmers' Market at Sandpoint, Inc. for the mutual benefit of the members of the Corporation; to provide a forum from which regional growers and makers can offer their products to the public; to provide for group purchasing of agricultural materials; to educate the public about agricultural products and concerns; to study the agricultural needs of members, and to do all things legally necessary and proper to conduct and furtherance the affairs of the Farmers' Market at Sandpoint.

FIFTH

The address of the initial registered office of the Corporation is: P.O. Box 52, Hope, Idaho 83836.

SIXTH

The Corporation shall have members. The affairs of the Corporation shall be managed by a Board of Directors elected by the membership.
