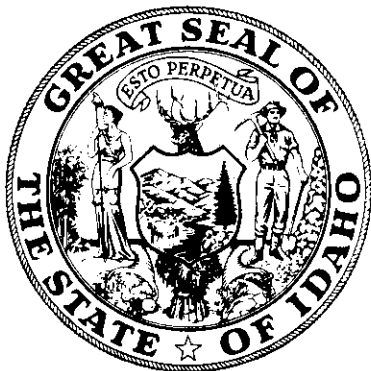

RESTATED ARTICLES OF INCORPORATION OF

Pursuant to the provisions of the Idaho Business Corporation Act, the undersigned corporation adopts the following Restated Articles of Incorporation:

FIRST: The name of the corporation is Idaho Lime, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of one class of common stock. The par value of said stock shall be \$100 per share.

FIFTH: Provisions for the regulation of the internal affairs of the corporation shall be governed by By-Laws adopted by the corporation.

SIXTH: The address of the initial registered office of the corporation is Main Street, Whitebird, Idaho 83554 (P. O. Box 105, Whitebird, Idaho 83554) and the name of its initial registered agent at such address is Press Thomas.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
