The following Statement of Domestication ("Statement") is executed by Broulim Rexburg Properties, LLC ("Company") pursuant to "Idaho Uniform Limited Liability Company Act", Idaho Code, Section 30-6-1001 and the "Idaho Entity Transactions Act", Idaho Code, Sections 30-18-501 through 30-18-503 which permit the Idaho domestication of a foreign limited liability company to domesticate in the State of Idaho by filing a Statement of Domestication which approves a plan of domestication, as follows:

1. **NAME.** The original name of the Company was BOYER REXBURG ASSOCIATES, LC. The name of the Company is now BROULIM REXBURG PROPERTIES, LLC.

2. **ORIGINAL FILING.** The Company originally filed Articles of Organization with the Utah Department of Commerce, Division of Corporations and Commercial Code (the "Division") on December 2, 1997 as Utah Entity Number 2043051-0160 ("Original Articles"). The Original Articles were amended by that amendment to Articles of Organization of Company filed with the Division on November 17, 2005 and the Second Amendment to Articles of Organization filed with the Division on December 8, 2010.

3. **TRANSFER JURISDICTION.** The Company filed Articles of Transfer with the Division on December 9, 2010 as Receipt Number 3405237, (a true and correct copy of which is attached hereto as Exhibit "A" and by this reference incorporated herein as though set forth in full) which sought to transfer domestication to the State of Idaho effective upon filing.

6. **PRINCIPAL OFFICE.** The complete street and mailing address of the initial principal office is 182 North State Street, Rigby, Idaho 83442.



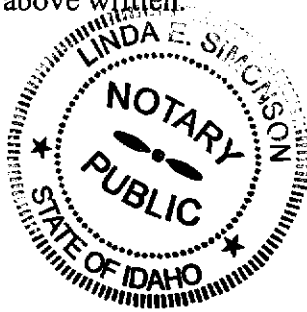
