ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

MERIDIAN DAIRY AND STOCK SHOWS, INC.

Bill Kell, President and Mark Jerome, Secretary respectfully shows that the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

The name of the corporation is Meridian Dairy and Stock Shows, Inc..

The following amendments of the articles of incorporation were adopted by the corporation:

Article II. Section 11.

The corporation is not organized for pecuniary profit nor shall it have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any member, director, or individual. The balance, if any, of all money received by the corporation from its operations, after the payment in full of all debts and obligations of the corporation of whatsoever kind and nature, shall be used and distributed exclusively for charitable, benevolent and public purposes.

Article XI.

In the event of the dissolution of this corporation, or in the event it shall cease to carry out the objects and purposes herein set forth, all the business, property, and assets of the corporation shall go and be distributed to such nonprofit charitable corporation or municipal corporations, as may be selected by the board of dir-

In no event shall any of the assets or property of this corporation, or the proceeds of any of said assets or property, in the event of the dissolution, thereof, go or be distributed to members, either for the reimbursement of any sum subscribed, donated, or contributed by such members, or for any other such purpose.

These amendments were adopted at a meeting of the membership of said corporation duly held on the 13th day of June, 1969, at Meridian, Idaho. At said meeting at which a quorum was present, the amendments were unanimously approved and the president and secretary authorized and directed to execute these Articles of Amendment.
