KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being natural persons of full age, all of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated themselves for the purposes of forming a private non-profit corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation as follows:

ARTICLE I

CORPORATE NAME

That the name of this corporation shall be KIWANIS CLUB OF KAMIAH, IDAHO, INC.

ARTICLE II

CORPORATE EXISTANCE

That the period of existance and duration of life of this corporation shall be perpetual.

ARTICLE III

NON-PROFIT CORPORATION

This corporation is to be a non-profit corporation under the laws of the State of Idaho. No part of the income of the corporation shall be distributable to the members, directors or officers.

ARTICLE IV

REGISTERED OFFICE AND INITIAL REGISTERED AGENT

ARTICLE V

CORPORATE PURPOSE

- 1. The purposes for which this organization is organized are as follows:
 - (a) To give primacy to the human and spiritual rather than to the material values of life.
 - (b) To encourage the daily living of the Golden Rule in all human relationships.
 - (c) To promote the adoption and the application of higher social, business, and professional standards.
 - (d) To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
 - (e) To provide through this club, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
 - (f) To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and good will.
 - (g) For the purposes aforesaid, to take over the assets, rights and franchises of the unincorporated club, known as the Kiwanis Club of Kamiah, Idaho, and its members.
 - (h) To do all such things as are incidental o conducive to the attainment of the above objects.
- 2. Management of the affairs of this corporation shall be vested in its board of directors to the extent as is set forth in the By Laws of the corporation.
