KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, all of whom are citizens of the UNITED STATES, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idahoi and each of us are of legal age.

We do hereby certify in writing the following:

l.

WHEREAS, TETON VALLEY is blessed with an abundance of natural beauty, fresh mountain air and sunshine, attractive mountains and canyons, from which spring clear mountain streams filled with fish life; evidencing superb recreational opportunities and with summer homes, ranches, farms, and with agricultural ranching operations and facilities for work experience for teen age boys and girls; and

WHEREAS, many parents of teenage boys and girls are seeking placement of their youngsters for a brief vacation period in the summers where working experience can be had and recreational opportunities provided under proper supervision and good moral standards;

NOW, THEREFORE, we the undersigned propose the following ennumerated purposes and powers:

- 1. To encourage the parents of teenage boys and girls to spend a short vacation in Teton Valley and to be provided with work experience and recreational opportunities.
- 2. To solicit membership in the Association to provide the teenage boys and girls with an opportunity for work experience on a farm, ranch, business, and opportunities for recreation such as hiking, camping, fishing, etc., and done under proper supervision and high moral environment.
- 3. To prepare and keep current a brochure of the educational-recreational opportunities and facilities in Teton Valley.
- 4. To advertise the aims and purposes of the Association by publication in suitable magazines, newspapers, radio and television media.
- 5. To write letters to L. D. S. Church Stake Presidents, Bishops, General Boards and other groups, soliciting teen-age boys and girls, boy and girl scout units, explorer posts and family units, of L. D. S. Standards to spend their summer vacation time in Teton Valley.

- 6. To screen applicants and thereafter place the applicants in qualified homes, on ranches or other facilities under the care and supervision of a member of the association, and thereafter provide guidance and assistance to the host member and his guest or guests for furtherance of educational-recreational opportunities during the vacation period.
- 7. To be the liason agent between the guest and his parents and the host-member of the association in arranging the finances on a weekly basis to cover expenses of room, board, educational-recreational activity, provided the teenage boy or girl during the vacation period.
- 8. To acquire an official seal for the corporation and to enter into contracts for the purchase of both real and personal property and to own and lease both real and personal property as are necessary in the pursuit of the purposes of said corporation.
- 9. And to do all things necessary or incidental for the accomplishment and achievement of bringing together American teenage boys and girls who can learn and play together in beautiful TETON VALLEY.

The name of said corporation shall be known as The Teton Valley Educational-Recreational Association, Incorporated.

The location of said corporation shall be in TETON VALLEY with Post Office Address, DRIGGS, IDAHO.

IV.

The corporation shall be non-stock, and no dividends or pecuniary benefits or profits shall be declared to the members thereof. A membership certificate shall be issued to each qualifying member of the association, who shall pay therefore an initial membership fee of \$10.00 (Ten Dollars) to help cover costs of advertising. The rights and interests of all members shall be equal, and no member can have or acquire a greater interest therein than any other member. The certificates shall not be assigned so that the transferee thereof can by such transfer become a member of the association, except by resplution of the board of directors and under such regulations as the by-laws may prescribe.

The period of existence and the duration of the life of this corporation shall be fifty years.

Vl.

The officers of this association shall consist of a President, Vice-President,

Secretary and Treasurer, and a chairman presiding over the five standing committees:

- 1. Advertising and publicity
- 2. Screening and placement
- 3. Legal, audit and insurance
- 4. Educational-recreational
- 5. Membership

The qualifications upon which members shall be accepted and expelled or reinstated shall be provided for in the by-laws of said corporation.

All other provisions relative to membership and election of officers and directors and the holding of meetings shall be provided for in the by-laws.
