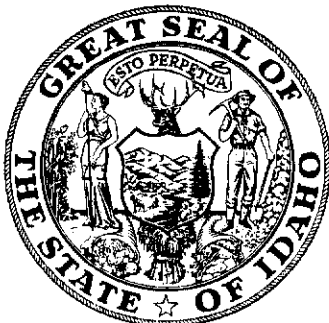

**ARTICLES OF INCORPORATION OF  
ROCKY MOUNTAIN FESTIVALS & EVENTS ASSOCIATION , INC.**

The undersigned, for the purposes of forming a corporation under the nonprofit laws of the State of Idaho, hereby adopts the following articles of incorporation.

**ARTICLE I.**

The name of this Corporation shall be Rocky Mountain Festivals & Events Association, Inc.

**ARTICLE II.**

This Corporation is organized for promoting the common business interests of those engaged in the festivals and events industry within the meaning of Section 501 (c) (6) of the International Revenue Code through advising, instructing and training individuals in basic festival and event planning, programming, management and publicity; and through promotion of the common interests of those engaged in the profession of producing festivals and events in communities throughout the world.

**ARTICLE III.**

This Corporation shall be operated in a manner and for the purposes set forth in Article II and shall have the power to carry on all activities necessary or incidental to such purposes.

**ARTICLE IV.**

The location of the registered offices of the Corporation in the State of Idaho is 7032 S. Eisenman Rd., Boise, ID 83705.

**ARTICLE V.**

The Corporation shall not permit pecuniary gain or profit to its members as a result of its activities directly or indirectly and is organized for nonprofit purposes and no part of the net earnings thereof shall inure to the benefit of any member or any other individual.

## **ARTICLE VI.**

The Corporation shall have no capital stock, but shall have members. The classes and qualifications of members, the conditions of membership and the voting and other rights and privileges of members shall be provided for in the By-Laws.

## **ARTICLE VII.**

The duration of this Corporation shall be perpetual.

## **ARTICLE VIII.**

No discrimination shall be made as to membership because of age, race, sex, color or creed.


ARTICLE XI.
