KNOW ALL MEN BY THESE PRESENTS: Pursuant to the Idaho Nonprofit Corporation Act (Idaho Code §§ 30-3-1, et, seq.) the undersigned, being natural citizens of full age and citizens of the United States of America, in order to form a Nonprofit Corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general laws of the State of Idaho, do hereby certify as follows:

## ARTICLE I: The Name of the Nonprofit Corporation

The name of the Corporation shall be "TWIN FALLS LIONS CHARITABLE FUND, INC."

### ARTICLE II: Existence

The period of existence and the duration of the life of this Corporation shall be perpetual.

#### ARTICLE III: Status

This Corporation shall be a non-profit association.

# ARTICLE IV: Registered Agent and Office

## ARTICLE V: Purpose, Nature and Objections

This Nonprofit Corporation is organized exclusively for educational and charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Service Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

This Corporation is not organized for profit, and no part of the net earnings of this Nonprofit Corporation shall inure to the benefit of any member of the Board of Directors or any other individual except that this Nonprofit Corporation may make payments of reasonable compensation for services rendered.

This Nonprofit Corporation is organized primarily for the nature, purpose and objective to provide an active interest in the civic, cultural, social and moral welfare of the community; to provide a forum for the open discussion of all matters of public interest, (provided, however, that partisan politics and sectarian religion shall not be debated by members); to provide an organization to receive charitable donations; to encourage service-minded people to serve and donate their time and money to their community without personal financial reward, and to encourage efficiency and promote high ethical standards in commerce, industry, professions, public works and private endeavors; and to engage in and provide funds for activities to enrich the lives of the community.

This Nonprofit Corporation's purpose shall include the right to conduct and transact any lawful activity.

Notwithstanding any provision of these Articles of Incorporation, the Nonprofit Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from

federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or, the corresponding provision of any future United States Internal Revenue law).

# ARTICLE VI: Membership

This Nonprofit Corporation shall have members who are citizens of the Magic Valley and who are Members in good standing of the TWIN FALLS LIONS CLUB, INC.

## ARTICLE VII: By-Laws

The members are specifically empowered to draft By-Laws as are necessary to govern the internal affairs of the Nonprofit Corporation. The By-Laws of the Nonprofit Corporation may be altered, amended, or new By-Laws adopted at any regular or special meeting of the Nonprofit Corporation called for that purpose by the affirmative vote of two-thirds of the total membership.
