ARTICLES OF INCORPORATION
OF
ROCKLAND TELEPHONE COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age and citizens of the United States of America, and residents of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

I.

That the name of said corporation is ROCKLAND TELEPHONE COMPANY, INC.

II.

That the purposes for which said corporation is formed are as follows: To establish, maintain and conduct a community telephone communications system for the purpose of servicing and benefiting all subscribers to such service, to carry on a general business for the benefit of customers and subscribers for both long distance and local telephonic communication, to maintain, construct and install all necessary communication lines and service equipment; to deal in either the purchase or sale of all necessary equipment, materials and machinery necessary to the operation of such business; to further render such personal service as necessary and advisable for the operation of such business and to do all things necessary or incidental to the carrying out of such business.

To own, rent, lease or maintain any building or buildings necessary for the housing and carrying on of the purposes of this corporation.

ARTICLES OF INCORPORATION - ROCKLAND TELEPHONE COMPANY, INC.

To own, rent, lease or maintain any and all personal property incidental to the carrying on of the purposes of such business.

To acquire, own, hold, sell, lease, purchase, mortgage or otherwise dispose of any property, real or personal, necessary to the operation of ROCKLAND TELEPHONE COMPANY, INC.

To deal in its own corporate stock, borrow money, contract debts, make contracts, and to exercise any and all such powers as a natural person can lawfully make, do, perform or exercise, which may be necessary, convenient or expedient for the accomplishment of any of its objectives or purposes, provided the same shall not be inconsistent with the laws of the State of Idaho, and that the end enumeration of such powers shall not be deemed conclusive. Such corporation shall have the power to own and acquire real and personal property of any and all descriptions necessary to the convenient carrying on of its business.

III.

That this corporation shall have perpetual existence.

IV.

That the location and post office address of the registered office of the corporation is Rockland, Idaho.

V.

That the total authorized number of par value shares is 50,000 shares of common stock of the par value of \$1.00 per share, each share of stock is equal to any other share and entitles the holder thereof to one (1) vote for each share of stock held by him. The total aggregate par value of the authorized shares is FIFTY THOUSAND DOLLARS & 00/100 (\$50,000.00).
