THAT WE, the undersigned, natural persons of full age, citizens and residents of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby certify as follows:

ARTICLE I.

The name of the Corporation shall be:

A. AND M. TRUCKING, INC.

ARTICLE II.

The Corporation is formed for the following purposes:

- For the interstate and intrastate transportation of goods over the highways, by virtue of a truck and trailer operation;
- 2. To own or lease trucks, trailers and other equipment necessary to accomplish the primary purpose stated;
- 3. For any other lawful business purpose which may be in any way incidental or related to the stated primary business purposes;
- 4. For the transaction of any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Idaho Code §30-1-1, et seq.

ARTICLE III.

The duration of the Corporation shall be perpetual.

The Corporation is authorized to issue one class of shares, in a total amount of 100,000 shares, each share of stock bearing a par value of \$1.00 per share. Shares of stock of this Corporation shall not be transferred or sold until said sale shall be approved by the Board of Directors of this Corporation, in accordance with the duly adopted Bylaws of this Corporation.

The Capital stock of this Corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.
