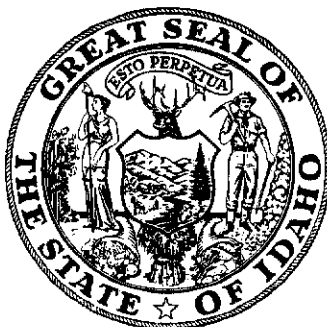

3. It is not transacting business in the State of Idaho.


4. It hereby surrenders its authority to transact business in said state.
