

ARTICLES OF INCORPORATION  
OF

CALDWELL TRANSPORTATION COMPANY, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I

NAME. The name of the corporation is, CALDWELL TRANSPORTATION COMPANY, INC.

Article II

DURATION. The period of its duration is perpetual.

Article III

PURPOSES. The purposes for which the corporation is organized are:

1. To own, purchase, lease, let, equip, maintain and work motor busses or other vehicles, appropriate for the carriage of passengers or goods, and to carry on the business of motor bus proprietors and carriers of passengers; to carry on the business of providing transportation for children to public and private schools; to purchase, construct, sell, hire or let motor busses, engines, machinery and other chattels and things used for any of the above purposes; to enter into contracts with any other person or company for the accomplishment of any of the above purposes, and to obtain all powers and authorities necessary to carry out or extend any of the above objectives.

2. To engage in the transaction of any or all other lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the Idaho Code and any amendments thereto.

Article IV

STOCK. The aggregate number of shares which the corporation shall have authority to issue is 100. Said stock shall be of one class designated as common stock with a par value of \$100.00 per share.




