of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the corporation laws of the State of Idaho do hereby execute and adopt these ARTICLES OF INCORPORATION, and we do hereby certify as follows, to-wit:

#### ARTICLE I

The name of this corporation is, and shall be: "HOMEDALE ROD AND GUN CLUB, INC."

#### ARTICLE II

The purposes for which this corporation is formed are as follows:

- To promote and instruct rifle and pistol practice and activities.
- To cooperate and affiliate with the National Rifle Association of America.
- To own, operate and maintain both indoor and outdoor rifle pistol ranges, trap and skeet fields, for the shooting of all 22 calibers and gauges of rifles, pistols and shot guns.
- To encourage the use of rifles and pistols, train and instruct membership in the use of all kinds of firearms, and to foster legislation against any unsound anti-gun law that would be detrimental to 26 any sportsman or honest gun owner.
  - To foster, perpetuate and promote activities for the presere. vation of wild life and fish in the State of Idaho.
  - To own, operate, maintain and control bird refuges, hatcheries, pens and equipment for the care and progation of wild life.
- To maintain, operate and own fish hatcheries and rearing 32 ponds for the hatching and propgation of all types of game and food 33 fishes.
- To cooperate with all public and private agencies for the 35 furtherance and developement of fish and game in the State of Idaho

- i. To print and publish magazines and literature advertising shooting activities, wild life and game fish in the State of Idaho:
- j. To purchase and receive as gifts, ammunition, guns, targets, and shooting supplies, hunting equipment of all kinds and nature, boats, canoes, motors, hunting and fishing clothing and equipment for and on behalf of members of this corporation in good standing;
- k. To maintain and build camp and hire personel and guides necessary in the operation thereof for and on behalf of the members of good standing in this corporation.
- 1. To operate and maintain on behalf of the club benefits and entertainment for the purpose of raising funds for the furthering of the purposes herein:
- m. To organize maintain and support junior rifle clubs and fish and game leagues;
- n. To own and possess by purchase or lease suitable building or buildings for club quarters, and to equip and provide said club building or buildings with such equipment libraries and supplies as may be necessary to the furtherance of the purposes hereof;
- o. To own and operate such trucks, automobiles, and motor vehicles as may be required for the operation under the purposes of this corporation:
- p. To receive donations of both real and personal property, and to do all and every thing incident to the betterment of shooting game, wild life, and fish for the sportsman of the State of Idaho and the United States all subject to the laws of the State of Idaho and the United States of America;

ARTICLE III

This corporation is to have perpetual existence.

ARTICLE IV

The location and postoffice address of the registered office of this corporation is Homedale, County of Owyhee, Idaho.

ARTICLE V

This corporation shall be a cooperative association organized not for profit and no dividends or pecuniary profits shall be declared

to the membership of this corporation.

The right and interest of all members of this corporation shall be equal and no member can have or acquire a greater interest in this corporation than any other member and this corporation shall not issue any captial stock, but shall issue membership certificates to each member, which certificates can not be assigned so that the transferee thereof can by such transfer become a member of this corporation.

## ARTICLE VII

The membership of this corporation shall consist of all persons of good character and repute over the age of 18 years who are willing to subscribed to the objects of this corporation subject to such 14 further requirements as may be established by the by-laws of this corporation.

## ARTICLE VIII
