AMENDMENT TO ARTICLES OF INCORPORATION

of

PARADISE VALLEY BIBLE CHURCH, INC.

KNOW ALL MEN BY THESE PRESENTS:

That at a regular meeting of the members held on the 20th day of February, 1970, the Articles of Incorporation of PARADISE VALLEY BIBLE CHURCH, INC., were amended by adding thereto the following:

TWELFTH: Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any of such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
