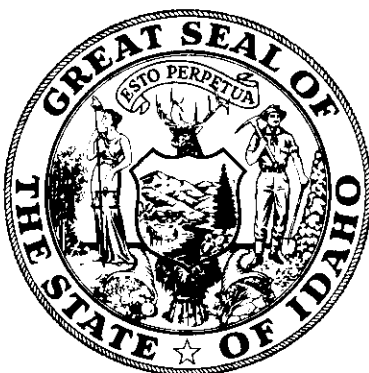

THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Nonprofit Corporation Act, as amended, adopts the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is WATER USERS' ASSOCIATION OF EAST MEADOW PARK SUBDIVISION, LATERAL, INC.

SECOND

The corporation is a nonprofit corporation. The period of its duration is perpetual.

THIRD

The purposes of the corporation shall include the following:

(1) To provide for distribution of water from the New York Canal to persons or lots within East Meadow Park Subdivision in Boise, Ada County, Idaho who or which are currently connected to the irrigation system;

(2) To exercise all rights and powers authorized for lateral-ditch water-users' associations pursuant to Chapter 13, Title 42, Idaho Code;

(3) To accomplish any other lawful purpose under the Idaho Nonprofit Corporation Act, as amended.

FOURTH

No dividend shall be paid and no part of the income of the corporation shall be distributable to its members, directors or officers.

FIFTH

The location of the initial registered office of the corporation is 2282 Cornhusk Court, Boise, Idaho 83706; and the name of its initial registered agent, who is at such address, is James J. Davis.

SIXTH

The number of directors constituting the initial Board of Directors is three; and the names and addresses of the persons who are to serve until the first annual meeting of the shareholders and until their successors are elected and qualified are:
