IN TESTIMONY WHEREOF, I have hereunto set my hand and affixed the Great Seal of the State. Done at Boise City, the Capital of Idaho, this 15th day of November, A.D., 19 66.

1 ARTICLE IV

2 The purposes for which this corporation is formed, and
3 is to be conducted and operated, are as follows:

4 1. To operate and maintain a Bible Baptist church
5 and to promote religious worship and to teach and preach the word
6 of God; to establish and maintain a place of worship and religious
7 education; and to carry on and conduct missionary, educational
8 and charitable work.

9 2. To purchase, acquire, hold, lease and take possess-
10 ion of, and enjoy in fee simple, or otherwise, any real or
11 personal property necessary or incident to, or in connection with
12 the purposes of the corporation, and to sell, lease, alien,
13 mortgage or otherwise hypothecate such property; and to borrow
14 money for the accomplishment of any of the above enumerated
15 purposes.

16 3. The above mentioned purposes shall also be consider-
17 ed as a statement of powers, and this corporation may do each
18 and every thing suitable or proper for the accomplishment or
19 attainment of any one or more thereof, or conducive to or
20 expedient for the interest or benefit of the corporation; in
21 addition thereto, the corporation shall have, and may exercise
22 any other or further rights, powers and privileges granted by
23 law to corporations of a religious character.

24 ARTICLE V

25 Puncuniary profit or gain is not the object of this
26 corporation, and it shall have no capital stock and all members
27 in good standing shall have an equal vote.

ARTICLE VI

1
2 The terms and qualifications for admission to member-
3 ship in this corporation shall be provided for in the bylaws of
4 the corporation.

ARTICLE VII

5
6 The government of this corporation and the management
7 of its affairs shall be vested in a board of three trustees,
8 to be elected by the members at the annual meeting of the corp-
9 oration, as provided in the bylaws. The trustees shall have such
10 powers as shall be conferred upon them by the bylaws of this
11 corporation and the articles of faith and constitution of the
12 Bible Baptist Church. No person shall be a trustee of this
13 corporation unless he is a member thereof, and a regular contrib-
14 utor to the support of the Church. Such Board shall select
15 from its own number a President, Vice-President and Secretary-
16 Treasurer.

ARTICLE VIII

17
18 That a duly called meeting of the members of this
19 corporation was held at the Church building of the Bible Baptist
20 Church of Buhl, in Buhl, Twin Falls County, Idaho, which said
21 church building is the place where said members regularly meet
22 for public worship and the transaction of business, on
23 the 1st day of November, 1966, at the hour of 8:00 o'clock
24 P. M., at which meeting a majority of the members who were
25 present voted for the election of directors; that due and regular
26 notice of the time and place of holding such meeting and election
27 was given by publication for at least two weeks in the Buhl
28 Herald, a weekly newspaper published and of general circulation

1 in Buhl, Twin Falls County, Idaho, the City where said election
2 was held, and was published in said paper on October 20 , 1966
3 and also on October 27 , 1966; and also by posting a like
4 notice in a conspicuous place on the building where said election
5 was held, which remained posted at all times from
6 1966, until the date of said election.

7 That at said meeting the following members were duly
8 elected directors of this corporation, by unanimous vote of
9 said members:

4 Pursuant to a vote of the trustees of the Bible Baptist
