



KNOW ALL MEN BY THESE PRESENTS, that Oregon-Washington Railroad & Navigation Company, is a corporation, duly organized under and by virtue of the laws of the State of Oregon, having a principal place of business in the City of Portland, Multnomah County, State of Oregon, and has been duly authorized and licensed to transact business in the State of Idaho, and maintains a place where the principal business of such corporation is carried on at the City of Lewiston, in said State.

That said Oregon-Washington Railroad & Navigation Company has made, constituted and appointed, and does hereby make, constitute and appoint FRED E. BUTLER, a citizen of the United States, and a citizen and resident of the State of Idaho, residing at Lewiston therein, and whose place of business is Lewiston, Idaho, its true and lawful agent for it and in its name, place and stead to accept service of process in any action or suit pertaining to the property, business or transactions of such corporation within the State of Idaho, in which such corporation may be a party, and

WHEREAS, L. M. Foss, residing at Lewiston, Idaho, has been heretofore constituted and appointed such agent, and it is now desired to revoke said appointment,

THEREFORE, Be It Known, that said corporation does hereby revoke, cancel and annul the appointment and authority of said L. M. Foss, as agent of said corporation in said State, and does hereby substitute as fully and completely as by law permitted or required, the said Fred E. Butler in his stead as aforesaid;

GIVING AND GRANTING unto the said FRED E. BUTLER full power and authority to do and perform every act and thing requisite and necessary to be done in and about the premises as fully and to all intents and purposes as the Oregon-Washington Railroad & Navigation Company might or could do if personally present, hereby ratifying and confirming all that the said Fred E. Butler shall lawfully do or cause to be done by authority hereof.

This Power of Attorney is irrevocable, except as provided by the laws of the State of Idaho.
