Pursuant to the provisions of Title 30, Chapter 3, of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Magic Valley Arts Council, Inc.

SECOND: The following amendments to the Articles of Incorporation were adopted by a quorum of the members of the corporation on April 24, 1989, in the manner prescribed by the Idaho Nonprofit Corporation Act:

Article III shall be deleted, and the following shall be substituted therefor:

"PURPOSE OF ORGANIZATION. This organization is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

up and dissolution the winding corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which is organized and charitable, educational, operated exclusively for religious and/or scientific purposes and which has exempt status under Section tax established its 501(c)(3) of the Internal Revenue Code.

The foregoing provisions shall apply notwithstanding any other provisions herein to the contrary."

Paragraph (i) of Article VII shall be deleted, and the following shall be substituted therefor:

"i. ADDRESS FOR NOTICE: The post office address of which the Secretary of State shall mail a copy of any notice required by law is:

THIRD: All classes of memberships of the corporation voted unanimously in favor of the amendments.
