ARTICLES OF INCORPORATION

OF

PECK'S, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, Title 30, Chapter 1, Idaho Code, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is PECK'S, INC..

SECOND: The period of the corporation's duration is perpetual.

THIRD: The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including, but not limited to, the wholesale and retail sale, distribution, manufacture and production of various products.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Two Hundred, (200), all of one class, at a par value of \$0.50.

FIFTH: Provisions denying preemptive rights are: None.

SIXTH: Provisions for the regulations of the internal affairs of the corporation are: None.

SEVENTH: The address of the initial registered office of the corporation is 5118 Highway 95, Potlatch, Idaho, and its mailing address is Route 2 Box 29, Potlatch, Idaho 83855, and the name of its initial registered agent at such address is M. Irene Bain.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

monetary damages for breach of fiduciary duty as a director, however, such provision shall not eliminate or limit the liability of a director:

a) For any breach of the director's duty of loyalty to the corporation or its stockholders.

b) For acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law.


c) For acts or omissions outlined in Idaho Code Section 30-1-48, now existing, and as it may be amended or modified.

d) For any transaction from which the director derived an improper personal benefit.
