# ARTICLES OF INCORPORATION

## NAME

1. The name of the corporation is T.A. WELDING AND MACHINE, INC.

## DURATION

2. The period of it's duration is perpetual.

## PURPOSE

3. The purpose or purposes for which this corporation is formed are as follows:
